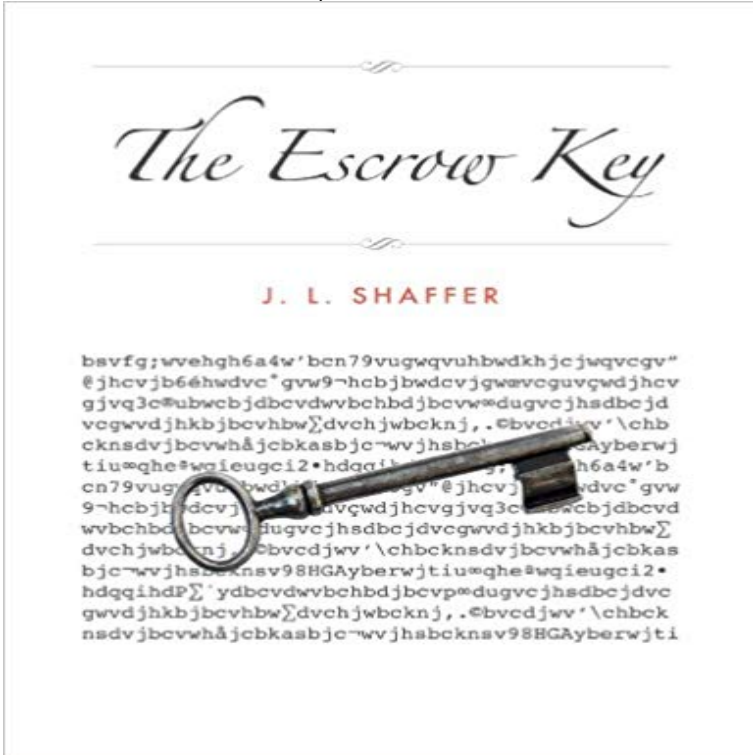


The Escrow Key
